

MINUTES OF LASALLE TOWNSHIP
REGULAR BOARD MEETING
February 18, 2020
7:00 P.M.

Item 1. Supervisor Goldsmith called the meeting to order @ 7:00 p.m. with the Pledge of Allegiance.
