- b. Fire Chief: As presented by Chief Howe, 34 calls for July 2022. The report included 27 medical calls, 9 P.I.A, 1 illegal burn, 1 fire alarm, 1 vehicle fire and 3 downed wire, and Mutual Aid 8 to Monroe Twp and 1 to Frenchtown Twp, had an average response time of 6 minutes, with an average of 6 firefighters per call.
- c. Attorney: Attorney Bondy's report presented by Supervisor Goldsmith. General Matters, Fire Department, Planning, Assessing & Building Matters.
- d. Blight Inspector: As presented by Jack Nida. Mr. Nida asked the board for permission to have the lot on the corner of Ave. D and Northshores Blvd mowed and the cost added to the tax bill for this parcel. **A MOTION** was made by Supervisor Goldsmith, supported by Clerk Morr to have the property on the corner of Ave. D and Northshores Blvd mowed and the cost added to the property tax bill. **The MOTION** carried 5-0.
