April 17, 2023

**Item 1.** Supervisor Goldsmith called the meeting to order @ 7:00 p.m. with the Pledge of Allegiance.

- b. Fire Chief: As presented by Chief Howe, 37 calls for March 2023. The report included 19 medical calls, 3 P.I.A, 2 odor investigation, 6 downed wire and 1 grass fire and mutual aid 5 to Monroe Twp and 1 to Erie Twp, had an average response time of 6 minutes, with an average of 6 firefighters per call. Chief Howe asked for approval to purchase a grass fire/field fire apparatus at a cost of approximately \$40,000.00. Chief Howe stated that the funds will come from the sale of the Recue truck that was just sold.  
A **MOTION** was made by Trustee Willis, supported by Treasurer Rauch to approve the purchase of a grass fire/field fire apparatus not to exceed \$40,000.00. **Roll Call Vote:** Supervisor Goldsmith-yes, Clerk Morr-yes, Treasurer Rauch-yes and Trustee Willis-yes. **The MOTION** carried 4-0.
