**Item 1.** Supervisor Goldsmith called the meeting to order @ 7:00 p.m. with the Pledge of Allegiance.

- a. Building Department: Mr. LaPointe reported 11 permits issued in December 2023 totaling \$1,269.00 collected in permit fees as presented.
- b. Fire Chief: As presented by Chief Howe, 30 calls for December 2023. The report included 18 medical calls, 4 P.I.A, 1 lift assists, 1 grass fire, 2 down wire, 1 combine fire, and 1 odor investigation, and mutual aid 2 to Monroe Twp, had an average response time of 6.0 minutes, with an average of 6 firefighters per call.  
Chief Howe informed the Board of the equipment lost when fire department basement flooded, Chief Howe presented a list of equipment that was lost due to water asked boards approval to purchase from list up to \$25,000.00 minus the \$6,800.00 from the new furnace and new hot tank that was already purchased. Chief Howe also asked to purchase new mustang suits due to them being outdated and faulty **A MOTION** was made by Trustee Anteau, supported by Trustee Willis to approve the purchase of suits thermal camera, gas meter and post pressure exhaust fan from insurance money and 4 new mustang suits from new equipment. **Roll Call Vote:** Trustee Anteau-yes, Supervisor Goldsmith-yes, Treasurer Rauch-yes, Clerk Morr-yes and Trustee Willis-yes. **The MOTION** carried 5-0.
